- Psychologists: Doctorate; a heavier emphasis on assessment, diagnosis, and treatment
- Social workers; Masters, link clients to community resources, diagnosis and treatment
- Mental health counselors; Masters, diagnosis and treatment
- Marriage & family therapists; Masters, diagnosis and treatment, marriage and family therapy

What Sets Professional Counselors Apart?

"A unique belief system about the best way to help people resolve emotional & personal issues & problems" (Remley & Herlihy, 2001)

A developmental approach to helping clients.

The Wellness Model vs. Medical Model

#### The Medical Model

- Goal: return patient to the level of functioning prior to illness
- Developed by physicians to treat physical illness
- The helper diagnoses & "cures" illness
  - Patient is diminished in some way
- Success: patient goes on about life
- If another illness negatively affects patient, s/he returns to be cured again
- Employed by psychiatrists, SW, & psychologists as a whole

Primary difference: attitude of helper

The Wellness Model vs. Medical Model

#### The Wellness Model

- Goal: positive mental health possible for <u>everyone</u> (wellness vs. cure illness)
- Mental health continuum (very mentally healthy dysfunctional/mentally ill)
- Most problems are developmental in nature, are normal, are natural
- When prevention is possible, counselors strive toward early intervention (vs. redemption) via education/training & involvement early in the process
- Implementation:
  - Holistically assess mental & emotional functioning in: relationships, career,
     spirituality, leisure, physical health, living environment, financial status, sexuality
  - Determine which factors are interfering with reaching maximum potential
  - GOAL: CLIENT EMPOWERMENT

### Perspectives on Competence

- Codes of ethics on competence have common themes:
- Counselors practice only within the boundaries of competence, based on:
  - Education (master's +, CACREP)
  - Training (post-masters, e.g., NBCC)
  - Supervised experience (during and post-degree)
  - State and national professional credentials
  - Appropriate professional experience
- A lack of competence = refer!

#### Accreditation – CACREP

- Council for Accreditation of Counseling and Related Educational Programs
- Mission: "...to promote the advancement of quality educational program offerings"
- Specialized accreditation Counselor Education Programs
- UCF is CACREP accredited



# Why is Accreditation Important?

- Quality meets the highest standards set by and for the profession.
  - Students will obtain the necessary knowledge and skills to be proficient in the counseling field.
  - Clients will benefit from the appropriate training of the counselor
- Certification & Licensure the application process is streamlined.
- Transportability lessens the stress of transporting your education and license/ certification
- Beyond the Master's Degree the advantage of a CACREP accredited master's degree

#### Licensure and Certification

#### Licensure

- governs professional practice
- highlights uniqueness of an occupation
- restricts both use of title and practice of occupation

#### Certification

voluntary attempt by a group to promote professional identity

- attempts to verify qualifications
- sets minimum standards
- does not assure quality practice

#### Licensure – The Florida Board

- Clinical Social Work, Marriage & Family Therapy & Mental Health Counseling
  - LMHC Licensed Mental Health Counselor
  - LMFT Licensed Marriage & Family Therapist
- Can diagnose & treat, as well as receive 3rd party reimbursement
- Your license is endorsed by the governor of Florida (who also appoints members to the Board)

#### More on LMHC

- Requirements
  - Masters in counseling or related (CACREP bonus!)
  - 60 hours of coursework
  - 1,000 hours of university-sponsored supervised clinical practicum, internship, or field experience (600 if CACREP)
  - 1500 hours of post-master's supervised exp (2 yrs post MS)
  - 100 hours of face-to-face supervision
  - NCMHC exam (NCMHCE)
  - Laws and Rules Course (8 hours)
  - HIV Course (3 hours)
  - Domestic Violence Courses (2 hours)
    - 25 hours of CEUs biannually to renew license

#### More on LMFT

- Requirements
  - Masters in counseling, focus on marriage and family (no CACREP bonus)
  - 36 hours of coursework
  - 180 hour (direct contact) supervised clinical practicum, internship, or field experience
  - 1500 hours of post-master's supervised exp (2 yrs post MS)
  - 100 hours of face-to-face supervision
  - National examination (Association of Marital and Family Therapy Regulatory Boards – AMFTRB)
  - Laws and Rules Course (8 hours)
  - HIV Course (3 hours)
  - Domestic Violence Courses (2 hours)

# Before the license – Registering as an Intern

- Register as an intern after you graduate and during your 2 year post-masters experience
  - Requires supervision by a qualified supervisor
  - The registered intern status is valid for 5 years
- With this provisional license, you can work with clients and get PAID
  - Some insurance companies reimburse registered interns, some do not.
  - It is unethical for your supervisor to bill insurance for your counseling sessions under his or her license.

# Since we' re talking about the Benjamins...

- Counselors' earnings can range from \$32,000-\$80,000 annually
- Here are the current mean salaries in US:
  - School & career counselors: \$53,610
  - Marriage and family therapists: \$43,210
  - Mental health counselors: \$43,990
  - Substance abuse counselors: \$38,520
